

OFFICIAL PROCEEDINGS
WASHINGTON COUNTY BOARD MEETING

SEPTEMBER 8, 2015

The reconvened and adjourned meeting of the County Board of Washington County, Illinois was held at the Community Center in Nashville, Illinois on September 8, 2015, for the purpose of transacting county business that might come before the board.

Present and presiding were Chairman David Meyer and Nancy Heseman, County Clerk and Clerk of the Board.

Others present were Linda Tragesser, Mitch Burdick, Rick Greten, Jim Dalaviras, Heath Hooks, Kent Ahlers, John Felchlia and Kelly Cameron.

Following the Lord's Prayer and the Pledge of Allegiance, Chairman Meyer called the meeting of the Washington County Board to order at 7:00 p.m.

Roll Call was taken by Clerk Heseman with 13 members present and 2 absent. Those present were Spenner, Shubert, Bening, Barczewski, Brammeier, Muentner, Gill, Lisk, Suedmeyer, Evans, Todd, Kurwicki and Meyer. Absent were Ibendahl and Hohlt.

Chairman Meyer asked if there were any corrections to the minutes of the Special County Board Meeting on August 20, 2015 and the regular scheduled County Board Meeting on August 11, 2015. With no corrections, a motion was made by Spenner and seconded by Muentner to accept the minutes as presented. Motion carried.

Mitch Burdick, County Engineer, had no resolutions but addressed the Board for informational purposes only. Mowing on the east side of the county is almost complete and will be moving to the west side next week. The project on Peach Tree Road had to slow down a bit, but looks like we will be getting the funding so they will be moving forward with this project.

The Claims Against the County Report was presented to the Board for approval.

TO THE CHAIRMAN AND MEMBERS OF THE BOARD: YOUR COMMITTEE ON SEPTEMBER 4, 2015, EXAMINED ALL CLAIMS PRESENTED AND RECOMMENDS PAYMENT TO THE FOLLOWING AND THE CLERK BE DIRECTED TO ISSUE ORDERS ON THE COUNTY TREASURER TO THE CLAIMANTS FOR THE AMOUNTS ALLOWED. **(See Exhibit A)** A motion was made by Evans and seconded by Gill to accept the report as presented. Roll call vote was taken with 13 ayes and 0 nays. Motion carried. Jeff Evans, Chairman of Claim Committee, informed the Board the next claims meeting will be on October 9th at 4:00 p.m.

The State's Attorney Monthly Report was presented to the Board. **(See Exhibit B)**. A motion was made by Brammeier and seconded by Bening to accept the report as presented. Motion carried.

The County Clerk & Recorder's Monthly Report was presented to the Board for Approval. **(See Exhibit C)**. A motion was made by Barczewski and seconded by Lisk to accept the report as presented. Motion carried. Clerk Heseman informed the new Blue Books are available now along with the County's Rate sheets.

The Sheriff's Monthly Report was presented to the Board for approval. **(See Exhibit D)** A motion was made by Kurwicki and seconded by Todd to accept the report as presented. Motion carried. It was reported the County now has 10 Federal inmates.

The Emergency Ambulance and Rescue Service Monthly Report were presented to the Board for approval. **(See Exhibit E)** A motion was made by Shubert and seconded by Spenner to accept the report as presented. Motion carried.

There was no Zoning to report on this month.

Kelly Cameron, Washington County Treasurer, reported to the County Board, stating the 2014 tax bills have been mailed with first installment being October 16 and seconded installment due on December 11, 2015.

At this time Chairman Meyer called for Committee reports.

Health Department: It was reported the Sanitarian, Linda Borowiak, has turned in her resignation and they will be in the process of filling this position.

Ambulance: Shubert stated they are looking into a proposed 20% increase in fees to take effect December 1, 2015. John Felchlia informed the Board last time there was a rate increase was 2011 and feels they are way past due for an increase to happen.

Building Committee: Gary Suedmeyer gave updates on the remodeling of the Courthouse. Gary informed the Board of some change orders that are not complete yet involving the additional concrete, drainage and widening of sidewalks. Gill moved and a seconded was made by Brammeier to give the Building Committee the approval to move forward on change order#1507.57 and #1507.58 concerning the concrete/drainage and sidewalks. Motion carried. with a nay vote from Todd. **(See Exhibit F)** With the remodeling project at an estimated 58% completed, they are hopeful that by the end of the year or first part of next year the project will be completed.

Ron Daniels, Regional Superintendent of Schools, appeared before the Board. He reported in the region we have 48 different school district, and he has one office in all four counties. There have been a lot of financial challenges and changes since he has taken office. He is working the Pre-k programs and grants that would all 4 counties. As an overall student enrollment is up slightly within the four county district.

A motion was made by Evans and seconded by Suedmeyer to pay all bills, utilities, payroll, overtime and insurance. Motion carried.

Meyer informed the rest of the Board about the UCCI Conference in Springfield, October 16-17, if anyone is interested in attending.

A motion was made by Kurwicki and seconded by Muentner to adjourn until October 13, 2015, at 7:00 p.m. Motion carried. The meeting of the Washington County Board was adjourned.
