OFFICIAL PROCEEDINGS WASHINGTON COUNTY BOARD RE-ORGANIZATIONAL MEETING DECEMBER 2, 2024

A re-organizational meeting was conducted at the Washington County Courthouse Nashville, Illinois on December 2, 2024. The purpose of the meeting was to elect a Chairman and Vice Chairman of the board.

Present and Presiding was Shari Hempen, County Clerk and Clerk of the Board.

Following the Lord's Prayer and the Pledge of Allegiance, Shari Hempen, County Clerk and Clerk of the Board called the meeting to order at 9:02 am
