OFFICIAL PROCEEDINGS WASHINGTON COUNTY BOARD MEETING MAY 17, 2022

The reconvened and adjourned meeting of the County Board of Washington County, Illinois was held at the Washington County Courthouse Nashville, Illinois on May 17, 2022 for the purpose of transacting county business that might come before the Board.

Present and presiding were Chairman David Meyer and Shari Hempen, County Clerk & Clerk of the Board

Others present were Matt Bierman-EMA, Debbie Stricker-Okawville Times, John Felchlia-Ambulance Administrator, Dan Janowski-State's Attorney, Kiefer Heiman-Highway Supervisor, Linda Tragresser-SWIMPAC, Charles Guffey-Centralia Sentinel, Sharon Mewes-Supervisor of Assessments, John Schubert & Sarah Lohman-South Central Transit, Michele Chesnek

Following the Lord's Prayer and the Pledge of Allegiance, Chairman Meyer called the meeting of the Washington County Board to order at 7:05 p.m.

Roll Call was taken by Clerk Hempen with 13 members present. Those present were Hohlt, Karg, Klingenberg, Lamczyk, Shemonic, Small, Suedmeyer, Todd, Unverfehrt, Barczewski, Bening, Brammeier, and Meyer.

Chairman Meyer asked if there were any corrections to the minutes of the Regular County Board Meeting on April 12, 2022, with no corrections or additions, a motion was made by Brammeier and seconded by Karg to approve the minutes as presented. Motion carried.

John Schubert President and Sarah Lohman Director of South Central Transit appeared before the board to introduce themselves and give the Board some information on SCT. SCT started business in 1999, they have 129 employees. They transport people from Perry, Jefferson, Clinton and Marion Counties for employment to Washington County. If anyone would like more information on SCT the information can be found on their website. (Informational only See exhibit A)

Dana Antoine former employee of Animal Control cancelled her request to come before the board.

Kiefer Heiman, County Engineer, brought before the board (RESOLUTION 2022-19) (See Exhibit B). Improve Federal Aid County Highway 10 by resurfacing and various improvements from the Village of Oakdale. A motion was made by Brammeier and seconded by Shemonic. Motion carried.

Kiefer Heiman, County Engineer, brought before the Board (RESOLUTION 2022-20) Oakdale Road District drainage structure on Hoover Road, TR 56, qualifies for replacement under the Illinois Township Bridge Program. (See Exhibit C). Heiman told the board that hopefully the construction will begin in the summer of 2023. A motion was made by Brammeier and seconded by Bening. Motion carried.

Kiefer Heiman, County Engineer, brought before the Board (RESOLUTION 2022-21) Replace a damaged drainage structure consisting of a 42" galvanized culvert on the south side of TR 197, Sugar Creek Road, south of Liberty Church Road Ashley Township, Section 31 2S 1W (See Exhibit D). A motion was made by Brammeier and seconded by Hohlt. Motion carried.

The Claims against the County Report was presented to the Board for approval by Ibendahl. TO THE CHAIRMAN AND MEMBERS OF THE BOARD: YOUR COMMITTEE ON MAY 9, 2022 EXAMINED ALL CLAIMS PRESENTED AND RECOMMENDS PAYMENT TO THE FOLLOWING AND THE CLERK BE DIRECTED TO ISSUE ORDER ON THE COUNTY TREASURER TO THE CLAIMANTS FOR THE AMOUNTS ALLOWED. (See Exhibit E) Motion was made by Ibendahl and seconded by Small to accept the report as presented. Roll call vote was taken with 13 ayes and 0 nays. Motion carried.

A motion was made by Bening and seconded by Karg to make restitution to the County Board's Per Diems. Motion carried.

The State's Attorney Monthly Report Janowski appeared before the Board to present his monthly report for approval. (See Exhibit F) A motion was made by Small and seconded by Hohlt to accept the report as presented. Motion carried.

The County Clerk and Recorder's Monthly Report County Clerk Hempen presented her report to the Board for approval. (See Exhibit G). She informed the board that early voting started on Thursday, May 19, but that there were objections at state level that could change the ballot certification. She would let the voter know and suggest that they come back in after the objections have been settled. Hempen also told the board that Donna her chief deputy has been working on Election grants. We have already received \$6798.98 and will be receiving an additional \$8420. A motion was made by Shemonic and seconded by Lamczyk to approve the report as presented.

Resolution #2022-22 (See Exhibit H) Chairman of the Board be hereby authorized to execute a deed of conveyance of County's interest or authorize the cancellation of the appropriate Certificates of Purchase on Permanent Parcel Number 15-14-02-307-018 Certificate #2018-0188. A motion was made by Klingenberg and seconded by Shemonic to give Chairman Meyer authorization to sign resolution. A roll call vote was taken with 13 ayes no nays.

The Sheriff's Monthly Report was presented to the Board for approval (See Exhibit I). A motion was made by Brammeier and seconded by Unverfehrt to approve the report as presented. Motion carried.

The Emergency Ambulance and Rescue Service Monthly Report John Felchlia Ambulance Administrator presented his report to the Board for approval. (See Exhibit J) Felchlia told the board that the 3rd week of May is EMS week and give a shout out to the EMTs for their good work. Felchlia also told the board that the last couple weeks have been busy with 1 or 2 calls at the same time, and that Breese and Pinckneyville Ambulance have been helping out to cover for Washington County. A motion was made by Small and seconded by Hohlt to approve the report as presented. Motion carried.

The Treasurer's Monthly Cash Flow Statement and Budgetary status Reports for Period ending 4/30/2022 (See Exhibits K & L). A motion was made by Karg and seconded by Brammeier to accept the report as presented subject to audit review. Motion carried. Also included was the ARPA Fund recap (Informational Only) (See Exhibit M).

Klingenberg asked if with the ARPA money that the County Board members could get laptops to save all the paper that is used for the meetings. Gary Suedmeyer said he will be scheduling a meeting with the ARPA board to discuss. Suedmeyer told the Board that the County Clerk received her first installment to digitize her records and that he has signed off on it so the office can move forward with the digitization. Todd asked about distributing some ARPA money to the County Fire departments. Suedmeyer said it was on the list.

Zoning – #S001-22(Ordinance 2022-06) for Special Use Permit (See Exhibit N). Michele Chesnek requesting the Granting of a Special Use Permit to allow: A seasonal produce stand along with a gift shop and pumpkin patch. Tabled from the April 12th Board meeting and sent back to committee. Chesnek and the adjacent land owner have an agreement amongst themselves. A fence will be put up around the whole property and make sure everything is up to

code. Todd made a motion to approve seconded by Lamczyk roll call vote was taken with 13 Ayes 0 Nays motion carried.

Zoning —#Z003-72 (Ordinance 2022-007) to amend Zoning Map (See Exhibit O). Karley & Kyle Dickinson request changing the Zone District Classification on 2.5 of 10.84 acres. Lamczyk made a motion to accept seconded by Karg roll call vote was taken with 13 ayes and no nays.

Zoning – #T002-22 (Resolution 2022-23) Regulating the Siting of Wind Energy Conversion Systems in Washington County (See Exhibit P). The County does not have an ordinance to regulate wind energy. The State is heavily regulating cell towers and solar farms trying to take control away from County Zoning authorities. This ordinance will help protect the county. It will be assessed by the State of Illinois formula. The towers are 600 feet tall from the tip of the blade to the bottom. They will last 40 years, the blades have to be changed every 10 years. Bierman stated as soon as Chairman Meyer signs the Ordinance it goes into effect. Effective May 17, 2022 Lamczyk made a motion to approve seconded by Shemonic Roll call vote was taken with 13 ayes and no nays. Motion carried.

ORDINANCE

REGULATING THE SITING OF WIND ENERGY CONVERSION SYSTEMS IN WASHINGTON COUNTY

WHEREAS, pursuant to Public Act 95-1027, it is the policy goal of the State of Illinois that 25% of electric energy consumed in the state by the year 2025 be generated from renewable resources; and

WHEREAS, such policy further states that 75% of the renewable resources must come from wind power; and

WHEREAS, the County of Washington, State of Illinois is authorized pursuant to 55 ILCS 5/5-12010 to establish standards for wind farms and electric generating wind devices, and may also regulate the siting of wind farms in the unincorporated areas of the county; and

WHEREAS, the County Board has heretofore adopted an Ordinance setting forth certain standards, regulations, and procedures for the safe and orderly development of wind energy conversion systems in Washington County; and

NOW, THEREFORE BE IT ORDAINED BY the County Board of Washington County that the WIND ENERGY CONVERSION SYSTEMS SITING Ordinance attached hereto and made a part hereof and subsequent text amendments found in exhibit A is hereby approved and adopted.
